

# **NOTICE OF NOMINATION MEETING (BY-ELECTION)**

## **ADAMS LAKE INDIAN BAND**

### **Notice is hereby given to the Electors (Voters) of the Adams Lake Indian Band**

There will be a meeting at the Old Band Hall 6430 Village Road IR#4 on Wednesday July 22, 2015 between the hours of 6pm to 8pm for the purpose of nominating candidates for the position of one (1) Councillor in the By-Election to be held Saturday August 22, 2015. A list of the eligible Electors is posted at the Adams Lake Indian Band Administration Office. Copies of the Adams Lake Indian Band Election Rules are available on line at [www.adamslakeband.org](http://www.adamslakeband.org) under C&C Elections Information or at the Adams Lake Indian Band Administration Office.

Any Elector who is unable to vote in person may vote by means of mail-in-ballots by contacting the Electoral Officer as per the contact information set out below. She/he will be required to provide proof of identity of eligibility to vote as required by the Electoral Officer.

The Qualifications for Candidacy for those persons seeking are as follows (in accordance with Part 7 of the 2014 Adams Lake Secwepemc Election Rules):

- (a) Be a registered ALIB member of Secwepemc ancestry;
- (b) Have attained the age of eighteen (18) as of the Election Date;
- (c) Be an eligible Candidate nominated for the office of Band Council pursuant to ALIB Election Rules;
- (d) Not have committed an Indictable Offence in the last five (5) years and have passed an acceptable Royal Canadian Mounted Police criminal records check (Appendix C of the ALIB Election Rules);
- (e) Be a resident within a 65 kilometer radius of any ALIB IR#1 to IR#7;
- (f) Not have an outstanding financial debt owing to the ALIB. (If there is a debt then a current payment plan shall be in place and such plan must be in good standing);
- (g) Not have committed a Corrupt Practice or Immoral Conduct determined to be of a serious nature;
- (h) Not have been convicted of an Indictable Offense; providing that conviction for an offense relating to the assertion or exercise of aboriginal rights or title, will not disqualify an individual;
- (i) Be prepared to pay a non-refundable two hundred-fifty (\$250) dollar nomination fee which must be paid before the close of the Nominations Meeting;

(j) Seek a pardon, if required.

**A Candidate may be nominated for one (1) position only.  
Documents required for nomination are listed in Part 13 of the 2014 Adams Lake Election Rules.**
