Under the guidance of Almighty God, Our Creator, and as a sovereign Nation; We, the peoples of Tsuut'ina Nation, in preservation and continuation of the Tsuut'ina Nation's unique culture. identity, traditions, language and institutions, and with respect to the special relationship to the land and resources, in continued relationship with all First Nations and Canada; Do ordain and establish this law in accordance with our inherent right to governance.

A Document to Ratify the L.AE.2112 Within the Tsuut'ina First Nation Lands

Enacted on December 7, 2021 in Tsuut'ina Nation Coming Into Force Upon Approval by The First Nations Tax Commission

Preamble

WHEREAS:

- A. Pursuant to section 5 of the *First Nations Fiscal Management Act*, the council of a first nation may make laws respecting taxation for local purposes of reserve lands and interest in reserve lands, including laws authorizing the expenditure of local revenues;
- B. The Council of the Tsuut'ina Nation has made a property assessment law and a property taxation law;
- C. Subsection 10(2) of the *First Nations Fiscal Management Act* requires a first nation that has made a property taxation law or a law under paragraph 591)(a.1) to make, at least once each year, a law establishing a budget for the expenditure of revenues raised under those laws; and
- D. The Council of the Tsuut'ina Nation wishes to establish an annual budget for the expenditure of revenues raised in the current taxation year, and wishes to authorize expenditures made in accordance with section 13.1 of the Act;

NOW THEREFORE the Council of the Tsuut'ina nation duly enacts as follows:

This Law may be cited as the Tsuut'ina Nation Annual Expenditure Law, 2021.

Definitions and Interpretations

Definitions

- 1. In this Law:
 - (a) "Act" means the First Nations Fiscal Management Act, S.C. 2005, c.9, and the regulations made under that Act;
 - (b) "Annual Budget" means a budget setting out the projected local revenues and projected expenditures of those local revenues during a budget year, and setting out expenditures made in accordance with section 13.1 of the Act;
 - (c) "Assessment Law" means the Tsuut'ina Nation Property Assessment Law, 2018;
 - (d) "Council" has the meaning given to that term in the Act;
 - (e) "First Nation" means the Tsuut'ina Nation, being a band named in the schedule to the Act;
 - (f) "Law" means this annual expenditure law enacted under paragraph 5(1)(b) of the Act as required by subsection 10(2) of the Act;
 - (g) "Local Revenues" means money raised by the First Nation under a local revenue law and payments made to a First Nation in lieu of a tax imposed by a law made under paragraph 5(1)(a) of the Act;
 - (h) **"Property Taxation Law"** means a law enacted by the First Nation under paragraph 5(1)(a) of the Act; and
 - (i) "Taxation Law" means the Tsuut'ina Nation Property Taxation Law, 2018.

Interpretations

- 2. The First Nation's annual budget for the budget year beginning April 1, 2021 and ending March 31, 2022 is attached as a Schedule and the expenditures provided for in the Schedule are authorized.
- 3. Expenditures of local revenues must be made only in accordance with the annual budget or in accordance with section 13.1 of the Act.
- 4. The expenditures made in the current year before this Law is enacted are included in the annual budget and are authorized by this Law.
- 5. Where the First Nation wishes to authorize an expenditure not authorized in this Law, or change the amount of an expenditure authorized, Council must amend this Law in accordance with Council procedure and the requirements of the Act.
- 6. This Law authorizes the expenditure of contingency amounts as necessary within any of the categories of expenditures set out in the Schedule.
- 7. Except where otherwise defined, words and expressions used in this Law have the meanings given to them in the Assessment Law and the Taxation Law.

- 8. Where a provision in this Law is expressed in the present tense, the provision applies to the circumstances as they arise.
- 9. This Law must be construed as being remedial and must be given such fair, large and liberal construction and interpretation as best ensures the attainment of its objectives.
- 10. The Schedule attached to this Law, including any Appendices, forms part of and is an integral part of this Law:
 - (a) A reference to the Schedule is a reference to the Schedule to this Law.
- 11. This Law comes into force and effect on the day after it is approved by the First Nations Tax Commission.
